### **Rabbit Buster Month**

February marks our annual 'Rabbit Buster' month campaign where landholders and communities are encouraged revisit their control plans.

Whilst Rabbit Buster field days have been postponsed until later in 2021, there is plenty to be done now. While the grass is dry and prior to autumn rains, numbers are usually at their lowest..

The Victorian Rabbit Action Network published the <u>'Rabbit Recipe'</u> in October 2020, advocating the following steps:

- Make an assessment of the rabbit population = *the size of your problem.*
- Following this, undertake and monitor a baiting program.
- Baiting should be followed by ripping. The deeper the better.
- Warren destruction is the key to effective rabbit control 'Destroy the warren, Destroy the rabbit'
- Continue monitoring on an ongoing basis to detect and treat any re-infestation of your property.

\*It is noted that dozer ripping is site specfic and can only be done where practical and culturally safe to do so.

### **Agriculture Victoria**

Ag Vic has a wealth of information to help you start or support your rabbit control program.

"Rabbit control is most cost effective in late summer and early autumn as breeding has generally paused at this time. Biological control and naturally harsh environmental conditions can cause added stress on the rabbit population and may lead to longer lasting results."

#### Controlling rabbit populations when they are low is the most cost effective control and efforts are more likely to be sustained.

Agriculture Victoria Biosecurity Officers are always willing to discuss rabbit control options with you.

### RabbitScan remains one of the most userfriendly tools to record rabbit populations.

RabbitScan is a free resource for landholders, Landcare groups, community groups, local Councils, professional pest controllers and biosecurity groups. It has been designed by landholders for communities, and it is very easy to use.

What to record:

- Rabbit activity (such as sightings and warrens).
- Damage, such as soil erosion.
- Control activities (such as warren ripping).
- Disease in rabbit populations (such as RHDV).

<u>The RabbitScan website</u> has all the information you need to use the webpage, download the app, and includes





supporting resources. You can even speak with a member of the RabbitScan team to organise some training for your local community.

#### **Rabbit Buster Field Days**

Each year, North Central CMA and Agriculture Victoria support a local landcare group or network in our region to host a 'Rabbit Buster' month demonstration field day.



The 2021 event was unable to take place this February, however the Buloke Northern Grampians Landcare Network will host the event later in the year in the Avon Plains area in partnerships with Ag Vic.

#### The <u>Landcare Farming Program team</u> will deliver a series of carbon footprint and natural capital accounting workshops nationally throughout 2021.

The Project Team is encouraging producers to apply if they are genuinely interested in knowing about carbon footprint and/or natural capital schemes. The workshops will show how the schemes underpin industry/sector sustainability strategy reporting, future investment, and potential new markets.

This project looks to develop an awareness and adoption pathway for on-farm integration. Both schemes offer new concepts to Australian agriculture producers and are increasingly aligned to stakeholder investment and reporting objectives. End-user input (producer input) is essential to move both schemes from 'proof of concept' and into standard agricultural management practices.

The Landcare network is uniquely placed to help deliver input and ground-truthing into how the concepts (and associated decision support tools) are developed, extended, and applied.

The workshops will include:

- 25 carbon footprint workshops, with 10 participants per workshop (250 participants).
- 25 natural capital accounting workshops with 10 participants per workshop (250 producers) and up to ten resource management experts for local support.
- Workshop participants completing the training will receive a tailored property report, comparison against industry benchmarks, and a personalised SWOT of their carbon/environmental account.
- Participants will have the opportunity to be accredited as natural capital accounting expert or develop their basic understanding of trade carbon.
   Each accreditation opens up potential new income streams for regional groups and landholders.

The blocks are located east of Bendigo and include the townships of Axedale, Goornong, Elmore, Rochester and Lockington.


Assessments of North Central Victorian Goldfields Ground Release tenders are well underway with a decision expected in March 2021.

Hi folks and Happy New Year to you all.

I hope everyone had a nice break over the festive season and enjoyed some nice times together with loved ones.

Not a great deal to report in this newsletter as we slowly ramp up for the year.

There has been a flurry of water quality monitoring going on since COVID guidelines have eased. I'm proud to say that since 1 October there have been **over 100** water testing events undertaken! This huge amount of monitoring simply could not be undertaken by staff. To know that we have such a dedicated army of volunteers keeping a watchful eye on our precious waterways is just so fantastic.

We are planning two new citizen science programs to commence this year. If you have an interest in the upper Campaspe River or our internationally significant Ramsar wetlands (Kerang and Gunbower) and are interested in becoming a citizen scientist, or know someone who might be, then watch this space.

These volunteers will provide significant data and contribute towards on ground works programs being rolled out by the North Central CMA to protect and enhance these significant waterways. Do get involved if you can.

It has been ages since the Waterwatch community has been able to get together or have any of our usual catch ups. I look forward to trying to catch up with many of you over the next few months.

### Best Practice Weed Hygiene Guide: Now Available

The new industry-first Best Practice Weed Hygiene Guide is aimed at improving the operations of staff and contractors, providing appropriate oversight and strategies to prevent the spread of weeds.

The guide provides recommendations on;


- planning site works,
- implementing weed hygiene practices, and
- contract management, capacity building and oversight.

The best practice guide was developed by the Victorian Serrated Tussock Woking Party (VSTWP) in collaboration with stakeholders, including a survey of land managers to understand the complex networks involved in weed management.

The survey established that three-quarters of respondents employed contractors to work on their land, with a range of formal and informal weed hygiene control mechanisms in place. However, only 20% audit their contractors annually or more often, with many reporting they have never conducted an audit.


