Never the less, amongst it all I managed to get out in the field to revisit some beautiful properties in Sidonia which were a part of the recently completed Kyneton Woodlands project. A few years since the fencing and planting works were undertaken, farmers in the area are really pleased with the results of the revegetation and woodland protection fencing, which is excluding stock from the myriad of palatable plants regenerating the area including kangaroo apple, callistemon, wattles and orchids.

The surrounding hills, roadsides and remnant patches within the farmland are dotted with stunning remnant woodland trees like this coverworthy, hollow bearing yellow box which adorns a farmer's driveway. I'm told that throughout its life this tree has been home to owls, possums, tuan, bats and bees.

National Volunteer Week saw North Central CMA undertake a social media campaign to promote volunteerism and celebrate the contribution Landcare and Waterwatch volunteers make to our community. We thank the incredible volunteers who contribute over \$1M in volunteer hours to landcare every year.

The announcement of the Victorian Landcare Grants opening on May 4 was exciting. We are really looking forward to seeing applications come in and are of course happy to assist with mapping your proposed project activities for assessment.

Looking ahead, we have a Landcare Network Facilitator meeting planned on June 26, where Darren and I will discuss the coming 12 months of regional Landcare activity and funding availability



to support Landcare events and capacity building across the catchment.

# 2018-19 Victorian Landcare Grants open

On May 4, the Victorian Government committed \$1.8 million for Victorian Landcare Grants in 2018-19 to support Landcare and other environmental volunteer groups to undertake projects that protect and restore the land and environment.

The process for submitting applications is online through SmartyGrants, however CMA's are utilising DELWP's SmartyGrants system, so you will note their logo when you enter the site.

# Applications Close: Tuesday 12 June 2018 at 12 noon

#### Funding:

- Project Grants of up to \$20,000 are available for on-ground works, education and capacity building projects to protect and restore Victoria's land and environment.
- **Support Grants of \$500** are available for existing groups/networks.
- Start-up Grants of \$500 are available for new groups/networks.

A total pool of around \$180,000 is available for our region.

Who can apply? the 2018-19 Victorian Landcare Grants are open to all Victorian Landcare and environmental volunteer groups and networks that advance the Landcare ethic and care for the environment. These include, but are not limited to Coastcare groups, Conservation Management Networks, "Friends of" groups, and Landcare groups/networks.

Reconciliation Week is happening across the Country between Sunday 27 May – Sunday 3 June, in recognition of two nation changing events; the 1967 Referendum and the historic Mabo decision. This year's theme is "Don't keep history a mystery - Learn. Share. Grow."

Reconciliation Victoria says, "National Reconciliation Week is an annual celebration and is a time for all Australians to reflect on our shared histories, and on the contributions and achievements of Aboriginal and Torres Strait Islander Peoples". The week is framed by two key events in Australia's history that provide strong symbols of the aspirations for reconciliation.

May 27 marks the anniversary of Australia's most successful referendum and a defining event in our nation's history. The 1967 Referendum saw over 90 per cent of Australians vote to give the Commonwealth the power to make laws for Aboriginal and Torres Strait Islander Peoples and recognise them in the national census.

June 3 is Mabo Day – On this day in 1992, the High Court of Australia delivered its landmark Mabo decision which overturned the notion of 'terra nullius' and legally recognised Aboriginal and Torres Strait Islander Peoples' connection to their country, a connection that existed prior to colonisation and continues today. This recognition paved the way for the Native Title system.

# **Spotlight on Threatened Species**

In a recent ABC radio interview, Upper Campaspe Landcare Network staff likened the greater glider to a "drunk fluffy cat up a tree". A wonderful descriptor to engage the imagination and interest of the general public, who like myself, have likely never seen one of these amazing creatures.

The UCLN, Macedon Ranges Shire Council and local landcare groups of the area are involved in a joint project to conduct citizen science surveys looking for three threatened species in the greater Wombat Forest area. The data collected from the surveys will be added to the Victorian Biodiversity Atlas to help protect these species and their habitat.

# Action Plan To Conserve Victoria's Wildlife

#### The Andrews Labor Government is managing the impacts of wildlife on Victorians and protecting and conserving our unique biodiversity.

The Living with Wildlife Action Plan aims to safeguard the conservation and protection of wildlife populations and wildlife welfare, and ensure the management of wildlife impacts is effective, sustainable and backed by science.

Victoria's native wildlife are a unique and valued part of our environment. It is critical they are managed in a way that ensures sustainable populations while protecting human health and safety, biodiversity, property and livelihoods.

The plan addresses community concerns relating to wildlife management issues, including wildlife becoming displaced or land-locked due to development and impacts of overabundant wildlife on biodiversity.

Victorians play an important role in conserving and caring for our wildlife, whether it be living alongside wildlife that live on or visit their property, or when they encounter wildlife in need of help.

The aim of the Living with Wildlife Action Plan is to ensure that:

1. Victoria's native wildlife populations are healthy and secure.

2. The management of wildlife is sustainable and underpinned by available scientific evidence and best practice.

3. All Victorians understand their roles and responsibilities relating to wildlife and are actively engaged in wildlife protection and conservation.

4. The Victorian community is confident in the government's actions to protect, conserve and manage wildlife

The plan includes reviewing the Authority to Control Wildlife System (ATCW) to ensure control methods are working effectively for land owners and the environment. Consultation on the ATCW review will start shortly.

## The sounds of success for plainswanderers

A song meter survey trial to find the elusive plains-wanderer (*Pedionomus torquatus*) in North-central Victoria has been a resounding success.

Department of Environment, Land, Water and Planning (DELWP) Natural Environment Program Officer, Bec James, said breeding females were recorded calling at 19 sites across Victoria's northern plains.

"Of the 19 sites, seven of them were already known to have birds in the area and six of them, according to our records, hadn't had plainswanderers living there for three to eight years.

"The most exciting result for us was that at six of the sites we recorded, plains-wanderers had never been seen there before," Ms James said.



Victoria Plains-wanderer Operation Group's Dr David Baker–Gabb said he installed 40 song meters across 13 sites on private and public land in September 2017 and collected the data in January 2018. "The data was then analysed and a computerbased Plains-wanderer call recogniser was developed by Dr Karen Rowe of Museums of Victoria and David Bryant from the Arthur Rylah Institute.

"With the call recogniser, we were delighted to find that six of the 19 active sites had recordings of two calling female plains-wanderers.

"Monitoring has been taking place in north central Victoria since 2010 and sadly there has been a massive decline since then.

"Our next step will be refining the best times of the day and night to record calls and work out how to stop other birds from pecking holes in the wind socks covering the microphones," Dr Baker-Gabb said.

The song meter survey work is funded with the support of the Victorian Government and the nocturnal monitoring was supported by funding from the Australian Government.

The plains-wanderer is listed as Threatened under the *Flora and Fauna Guarantee Act 1988* and listed as critically endangered under the Australian Government's *Environment Protection and Biodiversity Conservation Act 2016.* 

# A rush of brolga at Hird Swamp

Ecologist Damien Cook came across a magnificant treat during his recent wetland monitoring, sighting 11 brolga wading at Hird Swamp.



Hird Swamp, near Kerang, was the chosen location for the *2018 Breakfast with the Birds*. The site receives environmental water which regularly supports successful waterbird breeding events, including brolga.

# Helping farmers cut the red tape

The Australian Government has announced a targeted independent review to reduce redtape and find practical ways to help farmers meet the requirements of the *Environment Protection and Biodiversity Conservation Act* 1999 (the EPBC Act).

The review is being undertaken by Dr Wendy Craik. For review information and submission guidance visit

The review aims to deliver meaningful solutions and to identify actions that can be practically implemented in the short-term. It aims to improve regulatory clarity for farmers and to make sure the rules are sensible, with a particular focus on:

- Helping farmers understand when their activity does (or does not) require referral, assessment or approval under the *EPBC Act*.
- Ensuring environmental regulation is applied to farmers in a practical way, considering onground farming practices and minimising any duplication or conflict with state or local laws.
- Examining how farmers are informed and able to participate in the listing process for species and ecological communities, and the implications for them when a listing occurs.

# Sustainable Ag Snippet...

Two groups of farmers who completed a holistic management course at Tatura and Nagambie have decided to form a holistic management group. These farmers are incorporating the principles of holistic management to their properties.

The group meet on a regular basis and recently met at Sam and Miranda White's property at Sidonia. The aim of the meeting was to start the development of a holistic goal. The goal will interpret how the group will function as a whole and provide direction of what the group wants to achieve over time. To start the day there was a round table discussion on what's been happening in their district with the dry conditions a common theme throughout and everyone is 'rain ready'.

One comment that stuck in my mind was 'make decisions early and plan ahead' this is probably even more critical in times of little rain. Sam and Miranda run 500 head of cattle and their planned grazing techniques have got them through till now without hand feeding, which is amazing considering the dry conditions. Sam and Miranda still have a couple of paddocks ungrazed but it was time he needed to make some decisions regarding his cattle and the amount of feed he has in his paddocks.



This is where the group is very helpful in taking Sam and Miranda through three scenarios using the holistic managements seven testing questions, which will provide him with some direction on what his best options are. Ultimately Sam and Miranda will make the final decision once he has investigated the consequences of each option.

Since our meeting we have had some rain and Sam sent us all an email to say how good it is to get together 'It was great to host this meeting and see everyone here last Monday! It is always a boost to morale when we get together' and he also mentioned the rain 'Miranda and I got new perspectives from our discussions and also 22mm of lovely rain! Which is such a relief'. We are all looking forward to catching up again in June at Jim's property at Tatong, near Benalla, hopefully the group can provide similar support for Jim.

# Water for me, water for all - Educator Workshop

# 20 - 26 MAY 2018

During May each year we celebrate #SaltwatchWeek. Saltwatch week is an environmental monitoring program that helps communities understand the salinity problem in our waterways.

Saltwatch began in 1987, and is Australia's longest running community monitoring program.

During Saltwatch Week schools and community volunteers/groups from all over Victoria learn about the effects of salinity on water quality in their local catchment by collecting local water samples and testing with a salinity meter to determine salt content.

Saltwatch week coincided with Education Week in Victorian schools and we have encouraged all our River Detective schools to get involved. Snapshot monitoring provides a great opportunity to assess the condition of our waterways at a particular point in time.

The collaborative efforts of many registered groups create a picture of salinity across the state showing changes in salinity 'hot spots' over time, illustrating the effects of climatic changes such as the current drought, and can even pick up long term trends.

## **River Detectives - across the state**

To celebrate World Turtle Day (23 May), River Detectives schools across the state were invited to join a virtual learning session, on Monday 21 May, from the comfort of their own classroom and 'Ask the Expert' questions on turtles.



Our expert was Graham Stockfeld from Turtles Australia. Graham introduced the students to the three turtles: eastern long neck, Murray river short neck and broad shell which are all found in Victoria showing them the turtles differences through the camera.

The students were asked to create cut outs of the turtles to show the difference in their sizes! The students asked great questions of Graham, ranging from turtle diet, to why he started the project, turtle predators and what the students could do to help the species. Thanks to Graham for his passion and expertise!

# **Opera House Nets Banned in Victoria**

From 1 July 2019, opera house nets will be banned in all public and private waters throughout Victoria, with reforms that will benefit native animals that live in and around waterways including platypus and turtles.

Minister for Agriculture Jaala Pulford said opera house nets in Victoria will be phased out with new open top lift nets now more readily available to replace them.

Up until now, many fishers purchased opera house nets to target yabbies unaware they couldn't be used in public waters in Victoria. Open top lift nets can be used in both public and private waters and are proven to be effective yabby catchers.

As part of the changes, a one-for-one trade-in is planned, whereby fishers can trade in their old opera house nets for free 'wildlife friendly' open top lift nets.

Trials have indicated that wildlife friendly gear such as open top lift nets and hoop nets can catch more yabbies than opera house nets when fished actively, so it'll be even easier to put yabbies on the table.

The Victorian Fisheries Authority will work with the fishing tackle sector, anglers and environmental groups on an awareness campaign around 'wildlife friendly' yabby gear leading up to 1 July next year.

# Victorian Gorse Taskforce (VGT) Grants

The VGT Community Grants Program Community Grants is open until Tuesday 5 June. Groups of landowners or local Landcare Groups can attract up to \$30,000 in grants to help combat gorse in their local area.

## Horticulture Innovation Fund



The Victorian Government is encouraging innovation and collaboration in the horticulture sector with a new fund available for research and development projects that will help the sector remain profitable and sustainable into the future.

The Horticulture Innovation Fund (HIF) supports industry to partner with research organisations on projects that use new technologies and techniques for improving overall economic performance.

Through the HIF, the Victorian Government seeks to support a horticulture sector that is innovative, collaborative and well informed.

Grants of up to \$50,000 (excluding GST) are available for applied research and development

projects that contribute to a more productive and profitable horticulture sector. The program is open until 2019 and is administered by the Victorian Department of Economic Development, Jobs, Transport and Resources (DEDJTR).

# What will be funded?

Projects eligible for assistance from the HIF include:

- Applied horticultural research and development that is innovative and likely to improve farm performance, and/or
- Research that will improve market access and business diversification activities as applied to the horticulture sector.

Preference will be given to projects that are mid to late stage research, where adoption, piloting and/or trialling in Victoria is required.

All grant recipients will be required to share the results of the research through the Horticulture Centre of Excellence to facilitate learning across the sector and to encourage continued collaboration between industries.

# Who can apply?

The HIF is open to individuals and organisations associated with the Victorian horticulture sector, including:

Individual horticultural businesses – e.g. producers, coolstore/packhouse businesses, wineries.

Not for profit organisations that are an incorporated body, co-operative or association. e.g. industry bodies and associations.

**Research organisations** – a higher education institution or a registered research organisation
