A message from the Regional Landcare Coordinator

Hi everyone,

I've had a rather sheltered month of meetings, so didn't get out and about as often as I'd like. I did however spend a few days graciously soaking up the autumn air in Glenlyon for the first of two Chemical Users Courses for Landcare. Ten Landcarers completed the course, funded through the Victorian Landcare Program and delivered through Bendigo Tafe. The second booked out course will be in Kyneton. Given the high levels of interest, we will look to fund more courses in the 2018-19 year, so keep a lookout for these dates.

Mentioning the coming financial year is always a reminder to reflect on what the CMA Landcare Team has delivered across the region over the past 12 months. Darren and I have begun preparing reports back to the Victorian and Australian Governments, showcasing the North Central community's commitment, interest and knowledge exchange focussed on NRM and sustainable agriculture. We experienced fantastic participation numbers at our key annual events such as 'Chicks in the Sticks' (Walkers Lake) and the Future Farming Expo (Donald) as well as amazing landscape transformations from projects delivered through the Community Grants program.

Reports and data from the past four years of Landcare delivery, including community grants, will be collated and presented in the forthcoming North Central Landcare Support Plan, which is a key document demonstrating the CMA's commitment to supporting landcare across the catchment. The updated plan is due for release in July.

July just so happens to be the beginning of my extended leave. I'm travelling over to WA for an adventurous three-month break. During this period, CMA staff will be backfilling the RLC role,

Good news for Governance

On April 18, I crossed the border and headed to Euroa for a Governance Training workshop hosted by Goulburn Broken CMA.

The session was brilliantly delivered by Justice Connect, a non-for-profit law organisation, and was tailored for Landcare with a focus on governing a community organisation.

Whilst governance can sometimes be 'too hard' or 'too boring' a topic for committees to get engaged in (*and who can blame them!*), I came away with some great insights from the session which I thought I'd share;

- **Do you know your rules?** When was the last time your committee looked over the rules (*or constitution*). The rules set out the purpose of the group which should be reflected in decision making and implementation of actions.
- **It is important committees focus on Governance and Management?** Smaller Landcare groups members will be doing both roles, so setting time aside at meetings with your 'Governance' hat on is vital to ensure your group remains lawfully compliant to operate.
- **Committee culture is key.** Having a culture by which committee members are encouraged to question, investigate and disclose conflict is healthy and responsible. Committee members are legally responsible for ensuring the organisation operates within the law and legal duties.

Groups don't have to deal with everything at once, prioritising what are the most important actions that need to be taken (e.g. financial reconciliation, OHS issues, employment arrangements) and then acting, is crucial. Inaction is as much of an issue itself.

Landcare groups are certainly not expected to know the law, which is why Justice Connect provide really useful and informative guidance documents on their website for not-for-profit organisations. Visit:

Vale Terry Simpson

It with great sadness that the Buloke and Northern Grampians Landcare Network advised us of the death of Terry Simpson from Winjallock.

Terry, as an advisor on the Land Protection Council to the Honourable Joan Kirner (then Minister for Conservation, Forests and Lands with the Victorian State Government) was instrumental in bringing about the partnership between community based Landcare and the Victorian State Government to protect our natural resources.

It was on Terry's property at Winjallock on Tuesday November 25th 1986, that the Landcare Program was officially launched by Joan.

Landcare was originally intended as a program to involve farmers in land protection projects (hence the significant Victorian Farmers Federation involvement led by Heather Mitchell) but so successful has this grass movement become in delivering on-ground works and landscape change it has evolved far beyond that - from its beginnings at Winjallock, the Landcare Program has now grown to become a national and international movement involving people from all walks of life.

As a former Board member of the North Central Catchment Management Authority, Terry continued to be a strong advocate for Landcare and was particularly vocal about its origins as a farming movement and the need for it to continue to be of relevance and value to farmers given they had primary responsibility for managing somewhere near 70% of our landscapes – a sentiment shared by the Network

Our condolences to Terry's family and to his confidant, Jenny.

Towards a Healthy Little Coliban River~Tylden's Plant Propagators

The grade five and six class along with the grade prep class of Tylden Primary School recently participated in a Tylden Landcare program.

This part of the program involves the school in the Integrated Catchment Management Plan for the Coliban River system operated by the North Central CMA and Coliban Water; growing indigenous plants for revegetation along the Little Coliban River during 2018.

With the help of parents, staff and Tylden Landcare Group, children from the school spent time "pricking out" small plants from seedling trays and placing them into forestry tubes. The plants will then be kept for further growing and hardening off before planting along the river later this year.

James Stewart of Tylden Landcare and a recent graduate from CSU said "The students have enthusiastically embraced the program and have propagated indigenous trees, shrubs and grasses. Seed has been collected from local indigenous plants because these are most suited to local environmental conditions. The students are very aware that indigenous vegetation offers food and homes for native animals, prevents soil erosion and keeps the air clean. These plants will be planted along the Little Coliban River as part of the Coliban system Integrated Catchment Management program."

James added that Tylden students have played a role in Landcare projects over the years and that many of these plants will be planted along the Little Coliban River. Plants included Eucalypts, Acacias, Cassinnias and Lomandras.

Tylden Landcare is working with landholders along the Little Coliban River and the North Central CMA to protect and rehabilitate the Little Coliban to ensure a healthy water supply for farms and all users of the Coliban water storage system. The Little Coliban is a tributary of the Coliban River and contributes water inflow to the Upper Coliban Reservoir. A clean, healthy catchment ensures clean, healthy water for the future.

Along with parents, school staff assisted students on the day and said, "The senior students did a great job of passing on their plant propagation skills to the younger students!"

Joint Management Plan for Dja Dja Wurrung People



The Andrews Labor Government has released the first draft management plan for the Dja Dja Wurrung People – central to the cultural identity and well-being of Victorian Traditional Owner communities.

The draft plan translates the aspirations of the Dja Dja Wurrung People for their Country, and incorporates their traditional knowledge, culture and practices into the joint management of the parks and reserves.

The plan symbolises the partnership between the Dja Dja Wurrung People and the Government – and is only the second plan of its kind in Victoria.

In 2013 six parks and reserves in central Victoria were transferred into Aboriginal Title to be jointly managed by Dja Dja Wurrung people, Dja Dja Wurrung Clans Aboriginal and the Labor Government.

The parks and reserves under Aboriginal Title are



Hepburn Regional Park, Paddys Ranges State Park, Kooyoorra State Park, Wehla Conservation Reserve, Greater Bendigo National Park and Kara Kara State Park.

The Dhelkunya Dja Land Management Board was appointed to develop a Joint Management Plan in partnership with, and on behalf of, the Dja Dja Wurrung Clans Aboriginal Corporation and the Victorian Government for the parks and reserves under Aboriginal Title.

The parks and reserves will continue to be open for the enjoyment of the public and will protect and conserve significant cultural and environmental sites.

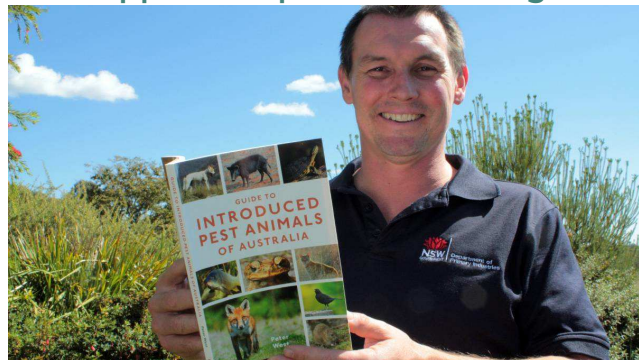
Traditional Owners and public land managers are working together in partnership, to share knowledge and skills and incorporate Traditional Owner culture into the joint management of parks and reserves.

The Government is supporting Traditional Owner interests through the *Traditional Owner Settlement Act*, which underpins Victoria's innovative model for joint management and recognises the ongoing connection of Traditional Owners to the land.

Feral app now a published field guide



In a modern-day twist, a popular app is now available as a book to help land managers and community groups identify and manage introduced pest animals.

NSW Department of Primary Industries (DPI) researcher and author, Peter West, said demand for a hard-copy version of the Field Guide to Pest Animals of Australia app drove publication of the new Guide to introduced pest animals of Australia.

"This handy, practical book identifies 60 introduced pest animal species, including 27 mammals, 18 birds, nine freshwater fish, four reptiles and two amphibians," Mr West said.

"The guide contains descriptive information to identify each species in the field, including distinctive physical characteristics, size, weight, colouration, diet, breeding behaviour, habitat preferences, and information about footprints, dung and animal calls.

"Each species profile is accompanied by practical management options, maps and high-quality photographs.

"The guide also contains a number of emerging high-risk pest species, which may pose a significant threat to our natural environment, economy, agriculture and human health.

"We expect farmers, land managers, pest animal controllers, teachers, students, field naturalists and wildlife ecologists to benefit from the guide."

The new guide, developed through a Centre for Invasive Species Solutions project, is available for purchase from CSIRO Publishing, with the still-popular app free to download for iOS devices.

Pick My Project is a community grants initiative, with \$30M available to fund local projects. Come up with an idea, vote for your favourites and make your community an even better place to live.

From May 2018, all you’ll need is a project idea to improve your neighbourhood and an eligible partner such as a registered community organisation, school or local council to help deliver your idea.

Victorian residents aged 16 and over will be able to submit their idea for consideration under the program. For participants under 18, parent or guardian approval will be required.

Projects can cost \$20,000 and \$200,000. Funding will be spread across the state, giving every community the chance to benefit.
