Eligibility Criteria

Grants are only available to non-profit, incorporated community groups (or groups sponsored by an incorporated organisation) that are involved in natural resource management for community benefit on private land or undertaking works on public land which is leased/licensed to a group member or is/could be managed by a community group. 'Community Groups' include Landcare, Committees of Management, 'Friends of' groups, Indigenous Communities, Field Naturalists/Plant groups, golf courses, and sporting associations. Schools and Local Governments are eligible where they can demonstrate that they are partnering a Landcare or other non-profit incorporated group.

To apply for any type of Second Generation Landcare Grant:

- 1. Check that your group meets the above eligibility criteria
- 2. Read the North Central CMA Second Generation Landcare Grants guidelines, and apply the General Criteria for funding to your project proposal so that your application will be looked upon favourably.
- 3. Ensure that you have acquired appropriate approval from, or made contact with, relevant officers or authorities **during the early stages of developing your project proposal** (if applicable). See Land Tenure & Approvals & Technical Advice boxes below.

If in doubt about how to proceed, contact the North Central CMA for advice.

All projects, including Final Reports, must be completed by the 31st of December 2010*

*An extension may be granted if necessary due to unforeseen circumstances or if in the best interests of the project objectives (e.g. optimum time to spray). If an extension is required, please apply in writing to the North Central CMA, explaining your circumstances.

Promotion & Education Grant

Eligible groups can use the Promotion & Education grant in two different (or both) ways – 'In-group' capacity building; or the group educating the wider community (beyond the group).

'In-group' capacity building: up to \$1000 can be used by community groups primarily involved in Natural Resource Management to increase group participation; raise public awareness about their group and its activities; and undertake training to improve the group's skill-base.
'General Community Education': up to \$2000 can be used to educate the community about the group's Natural Resource Management (NRM) programs; or about NRM issues etc. Activities could include field days; bus tours; education forums; surveys; monitoring, demonstrations, pamphlets/brochures, fact sheets. Themes could include remnant vegetation management, revegetation methods, habitat management, threatened species, salinity mitigation, Junior Landcare, sustainable landscapes, indigenous landscapes perspective, and so on.

- £ Landowner list completed if works are on private land
- DSE &/or Council advice/permit if existing native vegetation is to be affected by works
- £ DSE advice if threatened plant or animal species are involved in the project
- £ North Central CMA if river/creek or wetland is involved
- £ Public land (including roadside, rail reserve & Crown Land) involved checked with local council & DSE office first
- £ Known or possible sites of Aboriginal cultural significance consulted with Aboriginal Affairs Victoria, or contacted Parks Victoria, Epsom re: European sites
