



### 1. Scope

## 1.1 Landcare Support Policy

The policy outlines the level of support that the North Central Catchment Management Authority (CMA) will provide to the Landcare community from date of endorsement.

### 1.2 Policy development

The Shire-based Landcare coordinator model concluded 30 June 2009 due to changes in Australian Government investment programs that historically funded eight Landcare coordinators hosted by local government across the region.

In response to the issue of reduced Landcare support, the North Central CMA formed a Landcare Steering Committee consisting of a North Central CMA Board member, Natural Resource Management Committee member, the CEO and an Executive Manager. This committee determined that the necessary steps were to, through a North Central CMA staff working group and the Regional Landcare Coordinator, undertake a community consultation process.

The data collected will contribute to the development of a Landcare Support Policy and Landcare Support Implementation Plan, to be submitted to the North Central CMA Board for endorsement in August 2009.

# 1.3 Objective

The objective of the policy is to provide the greatest level of support to the Landcare community that is equitable and achievable across North Central Victoria with the resources available. Providing facilitation support to Landcare seeks to catalyse development and assist implementation of community-based initiatives that contribute to regional natural resource management outcomes.

# 1.4 Principles of support

Inclusiveness – ensure the Landcare community is represented in decision making


Commitment – commit to a shared vision for Landcare so that everyone's actions increases effectiveness

Transparency – make transparent decisions on all levels where Landcare support is concerned

### 1.5 Outcomes

Following delivery of the Landcare Support Implementation Plan, the North Central CMA expects to provide a level of support that will result in a Landcare community with an increased ability to:

- remain viable in the long-term
- match local needs with regional priorities
- have strong informal internal and external networks, including neighbouring groups and natural resource management agencies
- acquire improved skills to affect change in their own communities
- have access to information and resources to support natural resource management initiatives in their area
- develop and manage viable formal networks



- plan, implement and report on projects educate members to better manage their properties in a sustainable manner overcome problems, identify and work to enhance assets and locate resources to support local action.


### 2. Additional agencies
