That winning feeling

Warm congratulations to local Landcarers who returned from the 2009 Victorian Landcare Awards ceremony at Government House on 8 September with some of the big prizes.

The Department of Primary Industries Sustainable Farming Award for the North Central CMA region went to Andy Hay, whose interest in rehabilitating saline and degraded land led to the original project that kicked off the many achievements of the Northern United Forestry Group. Since offering that original plot for research and demonstration, Andy has been a tireless supporter of the work, and enthusiastically receives many visitors to his property.

North Central CMA knowledge broker Geoff Park won the Sir Sidney Plowman Travel and Study Award. Geoff is a trustee of the Norman Wettenhall Foundation, a member of the Newstead Landcare Group and one of the developers of the Investment Framework for Environmental Resources (INFER), an asset-based approach to environmental planning.

The Shire of Campaspe (which covers parts of both the North Central and Goulburn Broken CMA regions) was highly commended in the Local Government Landcare Partnerships Award.

As well, a Barapa Barapa Indigenous work crew, employed as part of the North Central CMA's Drought Employment Program, won an Australian Government Indigenous Landcare Award. The crew worked on a stretch of the Loddon River from Appin South to Kerang, assessing and recording cultural heritage sites as well as flora and fauna, river condition, fencing, erosion and weeds. The work crew is now a contender for the National Landcare Awards to be held in Canberra next year.

Congratulations to all the other nominees from our region. We acknowledge your achievements and commitment, and the Landcare community is proud of you all.

New Landcare policy and implementation plan

In June, the North Central CMA held a series of community consultation workshops across the region to give Landcare groups the opportunity to have input regarding future Landcare support following the reduction in Commonwealth funding.

Now the great input from these well-attended workshops has been used to inform the North Central CMA's Landcare Support Policy and an implementation plan for the next 12 months.

The North Central CMA intends to involve Landcare groups as partners in community engagement and project delivery, while supporting the community with projects that align with the Regional Catchment Strategy. Elements of the support policy include: providing timely information to the Landcare community; supporting the development and maintenance of groups and networks; providing opportunities for sharing knowledge and skills development; and seeking additional opportunities for Landcare funding support wherever possible, including new investors.

In particular, North Central CMA is keen to engage Landcare groups as service and information providers to deliver components of its programs and projects, and to promote and advocate Landcare's environmental and social benefits and outcomes.

Initiatives planned for the next 12 months include a grants calendar, training forums, a comprehensive list of key contacts including agencies, more frequent updates for the North Central CMA website, and this newsletter.

A copy of the Landcare Support Policy and the Implementation Plan has been sent to all Landcare groups with the Second Generation Landcare grants package, and to workshop participants. Census time

Attention all groups – Landcare is changing so this year's community NRM census is even more important, as it will provide guidance to those organisations assessing group needs, and help to secure government and community support.

The census, which has been running since 1991, gathers information about group characteristics, activities, outcomes and issues of concern. Information will be analysed by Professor Curtis.

You will be able to access a summary of the report through North Central CMA in early 2010.

The return date for the census form has been extended to the **1st December 2009**, but please return your form as soon as possible.

Championing biodiversity

Stay tuned for further reports on an interesting project starting up in the Hepburn, Pyrenees, Ballarat and Moorabool shires. 'Biodiversity Matters'- an initiative of Sustainability Victoria - will work with councils' planning departments to help them incorporate biodiversity issues into planning decisions.

The program will also train 'biodiversity champions' from local communities, who will link with new landholders. Likewise, local real estate agents will be asked to distribute an information kit. All good stuff.

Farm planning for horse owners

The Department of Primary Industries' Services and Information for New Landholders team, in conjunction with the FarmPlan 21 team, is developing a pilot program to assist horse property owners to manage their land in a sustainable manner.

Based on current whole farm planning courses, this will cover topics such as understanding and managing soils, pastures and weeds; biodiversity and catchment management; different horse keeping systems; and how horse owners can achieve their personal, financial, production and environmental goals in harmony with their horse interests.

The team is keen to hear from individuals and groups that would like the program presented in their areas. This could be a great opportunity for Landcare groups to initiate a program and engage horse owners, especially in small property areas.

Ready for action

The Australian Government's FarmReady initiative assists eligible farmers and Indigenous land managers to attend approved training courses through the Farm Ready Reimbursement Grants scheme. Up to \$1500 is available to individuals, who may also be eligible for additional support for travel, accommodation and child care expenses.

The range of approved courses is huge and includes business skills, planning and analysis; sustainable water and land use; farm planning; succession planning; grazing systems; soil management; water trading; ecology and biodiversity and even our own Box Ironbark Ecology Course. Approved providers include Bendigo Regional Institute of TAFE.

Note: you need to apply BEFORE you attend the course. You then submit the claim for reimbursement within 30 days of completing the course. For application and claim forms, and the full lists of courses and providers, go to http://www.farmready.gov.au/ or phone 1800 087 670.

FUNDING NEWS

Woolworths has announced a new \$1 million Sustainable Farming program that is open to Landcare groups. They are seeking applications from farmer groups, farming organisations and Landcare groups who wish to undertake projects in any primary production industry.

These grants are aimed at supporting farmers develop or implement good ideas to improve the sustainability of farming practices. The projects should develop or support the adoption of improved farming practices, production techniques, technology or products. Projects could focus on issues such as climate change adaptation, crop or animal production, water or nutrient use efficiency, waste management or salinity. The projects should also provide results of interest and benefit to other farmers. Innovative ideas that will share information about successful strategies for adapting to climate change and managing under variable rainfall are most welcome.
