### A message from the Regional Landcare Coordinator

Hi everyone,

Since the last Chat edition, there has been plenty of planning and preparation for the coming months of regional Landcare support and engagement activities.

I met with the Local Landcare facilitators on February 22 to discuss upcoming group and network activities, and identified areas where we can collaborate, which I am really looking forward to. The same can be said for the Victorian Landcare Team meeting, on February 17, where integrated CMA Landcare support actions were identified. The upcoming North Central and Goulburn Broken CMA Local Landcare Facilitators peer-to-peer networking forum in March was also discussed.

In late February I attended the Victorian Rabbit Action Network (VRAN) forum in Melbourne. The meeting brought together key land managers, community group representatives, rabbit management leaders and scientists to discuss the most practical methods for communicating and supporting the national release of the K5 Calici Virus, beginning March 6.

I encourage you to be a part of this national experiment by recording disease spread and rabbit sightings on <u>RabbitScan</u>. Given the investment Landcare projects make into restoring the landscape, particularly through revegetation, rabbits are a key species in shaping the success of many local programs.

Now I know the annual Landcare Health Survey isn't everyone's cup of tea, but the data collected from the 2016-17 Community Grants Landcare Health Survey is so valuable. The data has now been collated and is with the designer to produce the 2015-16 North Central Landcare Report Card.

### Landcare Victoria Inc.

The Farm Tree and Landcare Association and the Victorian Landcare Council (VLC) held a special general meeting in February 16, to formally approve the measures, which will merge the two organisations and move to the new Landcare Victoria Incorporated.

Landcare Victoria Inc. will take effect on April 3. This is more for information, as there is no wholesale change to the way in which groups are currently insured or incorporated and Susi Johnson will remain the key contact for groups in relation to these functions via <u>ftla@vff.org.au</u>

Further communications will be circulated by the organisation in the coming months about the committee and structure of Landcare Victoria Inc.

### **Child Safety Standards**

### As I mentioned in the February edition of the Chat, I attended a session on the Victorian Child Safety Standards (CSS) legislation, which came into effect on January 1, 2017.

After the very insightful session, I drafted an email to all Landcare Network Facilitators to disseminate through to groups.

The email included a few key messages and suggestions on working with the legislation that may assist those groups who are concerned or unsure about the effect of the CSS and its relation to Landcare activities.

In essence, the standards are not prescriptive about how to comply, which is intentional as the level of compliance/due diligence is going to be very different for a Landcare Group to a Preschool or Child Care Centre. It is likely that groups can self-determine if they are a Child Safe organisation, which is most certainly Landcare's intent.

### There are a few simple steps that your groups can take now as a minimum standard

• Create a **Statement of Commitment** to child safety, to be documented in your constitution, minutes, website etc. e.g. "The XXXX Landcare group is committed to providing a child safe environment and being a Child Safe organisation in accordance with the Victorian Child Safe Standards"

### **Twisted Science Success**

# Strathallan Family Landcare hosted a very successful Threatened Species Forum at the Twisted Science centre in Echuca on February 19.

Fifty people attended to hear from threatened species biologist Dan Harley, Wildlife Conservation and Science officer from Healesville Sanctuary who lead the discussion and gave directions about the work of Zoos Victoria in this field.





The group is very active on Facebook and promoted the event online, with flyers and through a display at the local library, which gained a lot of attention from a variety of age groups.

- A further step might be some **supporting principles** such as "The XXXX Landcare Group has zero tolerance of child abuse" "The XXXX Landcare Group will ensure all new volunteers are aware of our commitment to child safely when they are welcomed into the group"
- An Action Statement will assist your members to know exactly what to do should any issue arise and for reporting any suspected abuse e.g. "The XXXX Landcare Group will comply with Victorian Law by contacting the police in any instance that abuse toward children is suspected or witnessed"
- If you produce OHS/ Hazard Risk Assessments or Plans before your events, consider adding a line in specifically for the Safety of Children e.g. "This event is open to the general public, therefore parents are advised that their children remain their responsibility at all times"
- If working with schools, think about making the Standards part of the conversation with the teacher in charge when you're planning the logistics of the activity e.g. "What do we both need to do to ensure this activity/event/session provides a child safe environment?"

### **Economic benefits of Landcare**

For over 25 years, Landcare has improved the productivity of Australian agriculture through increasing the adoption of sustainable agricultural practices, which not only protect and enhance the productivity of our landscapes, but also improve yields and boost income for farmers.

The spread of these practices has had flow-on benefits for local economies, as farmers use more products and services from local suppliers and experts to meet the needs of their growing business.

### Re-snagging Pyramid Creek

# Ask any inland angler where the best spots to fish are and they will undoubtedly say "under a snag".

Last week, 26 snag complexes were installed in Pyramid Creek for fish habitat as part of a plan to boost native fish populations in the Gunbower and lower Loddon region. The timber will provide cover, resting sites, sites for food production and spawning sites for species such as Murray cod.

Box-Pyramid Creek is part of a 'fish highway' between the Murray River and important fish nursery habitat in Kow swamp. With construction of two fishways in the Little Murray River, optimisation of Kerang Weir fishway and construction of the Box Creek Fish Lock, migrating native fish such as golden and silver perch will have unrestricted access throughout 180km of waterways connected to 530 km of open Murray River. The snag complexes will provide important 'pit stops' along their journey.

Previous fish surveys indicate that the creek supports good populations of Murray cod, golden perch and silver perch. Further surveys are planned in autumn this year to see how fish are responding to their newly installed habitat.

The timber is 'pinned' to the stream bed ensuring that it doesn't dislodge under high flow conditions. Hydraulic modelling was undertaken to ensure that the snags do not increase flooding risk or reduce water conveyance down the creek for irrigators.

Waterway users should keep a lookout for snags

when boating, canoeing, fishing and swimming. The timber pins holding the snag complexes in place extend out of the water and are visible under normal flow conditions. The pins indicate the areas where the submerged snags are present and are usually situated near the stream banks.

The re-snagging is part of North Central CMA's Native Fish Recovery Plan, a large-scale and longterm plan to reconnect waterways for fish movement using fishways, implement fish friendly flows, and improve habitat in over 200 km of rivers and wetlands in the Gunbower and lower Loddon region. ### **Mineral Springs Makeover**

Willow removal works are now complete at the popular Kyneton Mineral Springs as part of the Caring for the Campaspe project funded by the Victorian government's Regional Riparian Action Plan.

Native revegetation in spring will further enhance the river environs. This completes a 3.5km section of rehabilitated section of the Campaspe River that was once heavily infested with invasive Crack Willow.

### Hello everyone

I hope you are all getting out and about in this beautiful weather!

February was a great month with lots of sunshine and catching up with volunteers, recruiting new volunteers and preparing for the River Detectives Program professional development workshops. I hope you are enjoying playing around on the new Waterwatch Victoria website, it's very exciting, and has some really great opportunities for data analysis and reporting. I have certainly been testing my skills on the new website and find myself side-tracked by all the new and fancy functions within the website, if you haven't had a chance to play, you should definitely get on and try it out!

The year is filling up with lots of exciting activities and events. Sophie has been working hard with program developers to get the state-wide River Detectives website ready to launch for 2017! This year we have 153 schools across Victoria participating in the program – this is huge for the River Detectives program, and demonstrates a desire within the education sector that resources that support sustainability are highly sought after.

At a local scale, I will be delivering three River Detectives professional development workshops at three locations across the catchment, this year we have 19 new schools joining us in the north central region and total of 37 schools registered. We will focus the first workshop on activities such as Water Science and providing training on how to use the new version on the website.

March is the perfect opportunity to get out with our team of citizen scientists to collect important aquatic ecological information about the health of our waterways. During March I will be hosting the Annual Agreed Level Taxonomy (ALT) workshop with John Gooderham from the Waterbug Company. John will be spending five days in the region training Bendigo TAFE students, Traditional Owners and Waterwatch volunteers. Participants will participate in an accredited workshop, which will allow them to gain the skills and technical knowledge required to collect and identify live waterbugs.

### Citizen Scientists helping to protect local waterways!

I would like to take this opportunity to welcome two new volunteers to the Waterwatch Program. During February I met with Margaret Lockwood and Kerrie Jennings and provided them with training and equipment to become local Waterwatch-ers on two of our precious waterways.

### Meet Margaret Lockwood

**Monitoring site:** NC\_LOD035, off Loddon River Drive

Waterway: Loddon River

Catchment: Loddon (Upper) Reach: 48

**Long-term resource condition target**: Improve the condition of waterways from moderate to good (based on the Index of Stream Condition) by 2050.

Margret is a member of the Glenlyon Upper Loddon Landcare Group and has registered as a volunteer to monitor the Loddon River at Glenlyon. The data from this site will contribute to developing a long-term data set for this site. The data will help inform a range of stakeholders about the area along with contributing to the Waterwatch water quality monitoring report. The report provides an insight into the overall health of our waterways using data collected by citizen scientists, further to this, the data can be used comparatively to understand if the site is meeting its long-term resource condition targets. Margret is aiming to build on her experience as a Waterwatch volunteer so she can share her knowledge with the younger generation. Margret is developing a program called "What's in Our Backyard at Glenlyon" with the local Landcare group and the Progress Association. She will be participating in our River Detectives professional development workshop and will deliver activities through the program that focus on waterway health with the youth of Glenlyon.



### Meet Kerrie Jennings

**Long term resource condition target:** Improve the condition of waterways from moderate to good (based on the Index of Stream Condition) by 2050

Kerrie lives on the Loddon River and is keen to learn more about her precious waterway. She is learning all about the birds that live on her property, the fish in the river and is keen to promote sustainability on the frontage of their 4 km stretch of Loddon River. It is timely that Kerrie undertakes water quality monitoring so she can begin to understand the local patterns in water quality, so she can use this information to help her make future decisions about property management to improve ecological health.

Kerrie volunteers her time in the local community of Baringhup and will be helping Cathy McCallum and staff at the Baringhup Primary school to deliver the River Detectives program with the students througout the year.

### River Detectives: a state-wide pilot project

Organisations across the state have been developing their plan to deliver the education approach, River Detectives, developed by North Central Catchment Management Authority's Waterwatch program.

As the River Detectives Project Officer, I have visited the organisations participating in the state-wide project armed with the equipment to make up their water quality kits. The kits will be provided to schools to test their local waterways and I was there to chat about ideas for the year ahead!

The road trip took me from the flat western plains (Wimmera CMA), heading close to the coast in Colac (Corangamite CMA) and the green north east of the state visiting the North East CMA. As well a quick stop off in the bustling city as Melbourne Water is also participating in the program supporting schools with their own kits. It was lovely to see the excitement at delivering the new approach in their region and the ideas for the future that could be added to continue to improve the program.



The revamped website is almost finished, so schools can input their data into the River Detectives portal which is connected to the new Waterwatch database. Some aspects will require a login while others with resources, what's happening and the chat forum not requiring a login. The CMAs across the state are running sessions to train teachers and educators coordinating activities with students at their local waterway. I look forward to sharing some stories of schools participating across the state.

### Electronic identification for sheep and goats

### From 1 January 2017, all sheep and goats born in Victoria will require an electronic identification tag, linked to the National Livestock Identification System (NLIS), before being dispatched to a saleyard, abattoir or another property.

The transition package has two phases and is a program of support, including funding, to help industry transition to an electronic NLIS (Sheep & Goats). Under the package, \$17.06 million is available, including:

- Cost neutral tags for producers for the first 12 months, at \$0.35 for the lowest priced electronic NLIS (Sheep) tag for 2017 lambs and kids
- Funding for:
  - the purchase and installation of infrastructure (including hardware and software) required to meet the regulatory obligations of an electronic NLIS (Sheep & Goats)
  - the purchase of optional infrastructure (including hardware and software) that will help industry benefit from the commercial opportunities associated with electronic identification
  - planning and design activities in saleyards and abattoirs
  - assistance to implement operational procedures; and
  - research and design to address an identified need within the supply chain.
- Access to technical support and consultants; and
- Training and extension activities

### Package assisting small exporters

The Package Assisting Small Exporters (PASE) is a \$15 million grant programme for small exporters administered by the Department of Agriculture and Water Resources. The PASE programme funds activities aimed at improving market access for small exporters.

Funding is available for projects in 2016-17 to 2017-18.

# Applications for Round 2 funding are now open and applications must be lodged by 5:00pm AEDT on 27 March 2017.

Eligible commodities for PASE grants include:

- dairy
- egg
- fish
- grain
- horticulture
- plant
- meat.

### Managing Farm Risk Programme

The Managing Farm Risk Programme is open for applications

The Managing Farm Risk Programme provides rebates for advice and assessments to help farmers prepare and apply for a new insurance policy that assists with the management of drought and other production and market risks.

These one-off rebates will cover half of the costs incurred by eligible farm businesses, up to a maximum of \$2 500 (GST exclusive). The rebates are not for insurance policy premiums.

Insurance can significantly reduce the financial risks farmers face from production loss caused by factors beyond their control. The Australian Government understands that insurance for risks—like adverse weather, drought and fluctuating markets—can protect profits and give farmers peace of mind, but identifying and choosing suitable insurance can be challenging.

That's why the Australian Government is providing \$20.2 million over four years help farmers with their decision making.

The Managing Farm Risk Programme is part of the Australian Government's Agricultural Competitiveness White Paper, the government's plan to grow our agriculture sector for stronger farmers and a stronger economy.
