# Revegetation survival monitoring

Landcare, Coastcare and other environmental volunteer groups/networks and individuals that have or are undertaking revegetation activities in 2019 are invited to participate in a project to monitor the survival rate of these revegetation plantings

This revegetation monitoring work will contribute to the 'Monitoring Revegetation Activities – Adaptive Learning Project' that is being undertaken by La Trobe University and the Arthur Rylah Institute, Department of Environment, Land, Water & Planning (DELWP).

The project aims to:

- assess the outcomes of revegetation, in terms of the survival of planted trees, shrubs and understory plants;
- determine the factors that affect variation in survival among different species, and different regions;
- develop a monitoring protocol that community groups can use to collect information in a standard way to monitor planting outcomes.

Monitoring revegetation sites will require the use of a simple monitoring protocol including;

- monitoring revegetation activities data sheet with details about how to do the monitoring,
- monitoring the outcomes of revegetation fact sheet, including results from revegetation monitoring in 2018

Sacha is open to providing training to group members in monitoring methods if Landcare or Coastcare Facilitators can organise participants for the training




Figure 1: An example of the monitoring plot used to assess plant survival in Tubestock plantings.

### **Biodiversity Month**


Biodiversity Month is held in September each year and aims to promote the importance of protecting, conserving and improving biodiversity both within Australia and across the world.

Biodiversity is all components of the living world: the number and variety of native plants, animals and other living things across our land, rivers, coast, and ocean.

There are several ways biodiversity activities and data is captured across Victoria but one simple and effective way to capture everyday observations of species in your local environment is through our NatureBlitz app or our webpage.

NatureBlitz allows you to record information relating to birds, fish, frogs, mammals and reptiles. Data is verified by the Waterwatch team before feeding up into the Victorian Biodiversity Atlas and the Atlas of Living Australia.

Did you know, more than 390 records are now in Natureblitz. Could September be the month we break the 400-record mark?

# Protecting Recreational And Aboriginal Water Values

During August, recreational and Aboriginal water values were enshrined into law for the first time across Victoria with legislation passing the Upper House in Parliament.

The Water and Catchment Legislation Amendment Bill 2019 will embed recreational and Aboriginal cultural values into the planning and operations of water resource managers.

The Bill provides:

- greater consideration of the recreational values of water and waterways for communities
- greater recognition and involvement of Traditional Owners and Aboriginal Victorians in the management and planning of waterways and catchments and;
- clearer planning for future challenges such as climate change, population growth and changing demands for water.

This legislation will support Aboriginal cultural uses of water and underpins opportunities to use water for economic development for Traditional Owners and Aboriginal Victorians. It will also support the self-determination of Traditional Owners by providing opportunities that best meet their water management needs.

Greater consideration for recreational and Aboriginal values will not compromise core responsibilities of water corporations to deliver high quality water for communities and water for entitlement holders when they need it.

# HAVE YOUR SAY: Parks Victoria's Land Management Strategy

Parks Victoria is pleased to announce that the Draft Aspiration Statement and Guiding Principles for the Land Management Strategy have been released for stakeholder and community feedback.

Commencing in early 2019, Parks Victoria embarked on developing a state-wide Land Management Strategy (LMS) for the park estate. Directed by the *Parks Victoria Act (2018)*, the LMS sets out the general long-term directions, strategies and priorities for the protection, management and use of Parks Victoria managed land'. The LMS covers all of the Parks Victoria estate; four million hectares across 3,000 land and

marine parks across the state – which accounts for 18 per cent of Victoria's land and 70 per cent of its coastline.

The Strategy articulates how the parks estate responds to change and develops over time and will be used to guide more detailed planning and decision-making. Following completion, the LMS will be the key strategic document for Parks Victoria to guide the management of the parks estate.

The Draft Aspiration Statement and Guiding Principles have been developed through an extensive internal Parks Victoria engagement process that included a series of regional workshops and an internal digital platform where staff provided their input.

Parks Victoria is now seeking feedback from key stakeholders and the community on the Draft Aspiration and Statement and Guiding principles.

### Regenerative Ag Project update

The Regional Agriculture Landcare Facilitator is assisting one of the Regenerative Agriculture project groups to form a community of practice (CoP) located in the Talbot district. The group meets every six weeks to discuss and plan future activities. A meeting was held in August in Brendan Roughead's shearing shed. The group was enthusiastic about the activities planned for the year, including multi-species cover crops and applying bio-stimulants, with the aim of increasing soil microbial activity and soil health. The multi-species cover crops will also contribute to increased ground cover and filling feed gaps over spring and summer.

Jade Killoran from AGF Seeds attended the meeting to provide advice on species selection, timing for sowing and will assist the group with monitoring and advice on grazing in the future. After the meeting the group went out in to the paddock to look at a mixed pasture sown in May, everything was growing well but Brendan mentioned that most of the Lucerne died due to the wet conditions. Eventually the discussion turned to the weather, and with a prediction of dry conditions over spring the question was when will be the best time to sow. After a quick discussion the consensus was to sow in spring with species known to germinate in cooler soil temperature to minimise the risk.

The group has also engaged Dr Christine Jones to run a soil health workshop in September, which has already been booked out. Having Christine present to farmers will be of great value to the group and wider community, which will build on their knowledge for future decisions.

The group is very keen to undertake activities on their properties and have a common goal of improving their soils, sharing knowledge and learning from each other. This will provide a solid foundation for the group in to the future.

# Works on Waterways - Help us do better

North Central CMA has a legal statutory authority and responsibility to protect our waterways. Within the scope of this role we monitor, administer and enforce control over all works which may impact upon designated waterways throughout the north central region.

Anyone planning on undertaking works within a designated waterway must obtain a Works on Waterway Permit from the North Central CMA. There is no cost to obtain a permit and obtaining a permit will help ensure that the proposed works are designed appropriately.

To protect our rivers and creeks it is important that new activities or works undertaken do not adversely affect the health of our waterways. Unfortunately, some works are undertaken without the necessary approvals and North Central CMA is working to address unauthorised works through our compliance process.

Our catchment is large, and it is hard to always know when and where unauthorised works are occurring without help from the public. So, if you see any suspicious or potentially unauthorised works occurring in or around our waterways (i.e. machinery in a waterway, vegetation clearing, a dam being built on a waterway) please contact us via phone at (03) 5440 1890 or email floodplain@nccma.vic.gov.au.

You can remain anonymous. If you can take photos and/or provide a detailed description of what's occurring and where that would be great as it makes our investigations much easier. We have only 12 months from when the unauthorised works occur to act, so it is important that if you see something happening you let us know straight away so we can do something about it.

### **Litter Trackers for Bendigo Creek**

You might recall in last month's Chat, we mentioned a workshop with our Bendigo Creek River Detectives creating their vision for Bendigo Creek. Litter was a recurring theme in the student's vision, and the project has continued to develop with the deployment of five litter trackers in the creek in late August.

Quite simply, trackers are a sealed plastic bottle with a GPS inside to track how and where our litter travels. We can then watch where the bottles travel (along with regular litter), via an online map. After four weeks (and hopefully some good rains!) we retrieve the bottles and work with the students to:

- Learn why litter is an important environmental issue.
- Learn how it travels and if extreme weather conditions affect the litter journey.
- Understand how litter can remain trapped in our waterways, impacting waterway health and aquatic wildlife.
- Increase awareness of local waterway values and the connections between catchment activities and waterway health.

The launch on Tuesday 26 August, was a great opportunity for students to come together with some key agency staff, RMIT researchers and VIPs, including Mayor Margaret O'Rourke and North Central CMA Chair Julie Miller Markoff. Students got to litter for a good cause and were excited to throw the trackers in to the creek at Golden Square. We will report back on the progress of the trackers in a future edition of Chat, so watch this space!

Bendigo Creek Litter Trackers is a partnership between North Central CMA, City of Greater Bendigo and RMIT University, supported by the Victorian Government.


## 22nd Annual Wimmera Biodiversity Seminar

# Funding opportunities....

### **Communities Environment Program**

The Australian Government has announced a one-off grants program, the Communities Environment Program. This program will support small scale, community-led environment projects that address local environmental priorities across the country.

Project funding: from \$2,500 to \$20,000 may be available for eligible projects.

Guidelines: go to

https://www.business.gov.au/assistance/commun ities-environment-program Guidelines, Fact Sheet, Frequently Asked Questions, Sample Application

Eligibility criteria: to be eligible you must:

- be invited to apply by your MP
- have an Australian Business Number (ABN)
- be either an incorporated entity or have a project sponsor who meets the eligibility criteria who can apply for a grant.

Funding available: each of the 151 federal electorates across Australia will receive up to \$150,000 for allocation to successful applicants. The total pool of grant funding for the Communities Environment Program is \$22.65 million.

How many projects will be funded: a maximum of 20 projects will be funded in each federal electorate.

#### Types of projects that may be funded:

The following types of projects are a guide to the types of projects that may be funded:

- protecting native animals, and supporting recovery of threatened species
- control of invasive weeds and pest animals
- seed collection, propagation and planting to increase habitat/linkages, and rehabilitate riverbanks, waterways,
- wetlands, coasts, and control erosion
- monitoring flora, fauna, water quality and;
- waste and litter reduction.

Please ensure you read the grant's Guidelines prior to submitting your Expression of Interest. All proposals will be reviewed within the Guidelines. A shortlist of applicants will then be invited by local MPs to submit a formal application to the Department of Industry, Innovation and Science.

# Project completion date: projects must be completed by 31 December 2020

Note: an invitation to apply will not guarantee the grant funding, as organisations and projects are required to meet the eligibility criteria as outlined in the Guidelines.

### **Stronger Communities Program**

Similarly, to the CEP program, round 5 of the Stronger Communities Program is being handled through an initial Expressions of Interest process which must be submitted through your Federal electorate office.

The SCP program will fund up to 50% of eligible project costs, with 50% of matched funding required from the applicant. You must complete your project within six months of your project start date and no later than 30 June 2020.

#### Types of projects that may be funded:

- upgrade or installation of park furniture including shade/shelters, BBQs, toilet facilities, drinking fountains
- development or upgrade of bike paths, streetscapes, skate parks or community gardens
- upgrade of facilities to provide inclusive access

**Funding available**: The Australian Government's funding commitment for Round Five is \$22.65 million, with funding of up to \$150,000 available for each electorate. A maximum of 20 projects will be funded in each electorate, with successful projects receiving a grant between \$2,500 and \$20,000.

### Youth engagement grants program

Grants of up to \$15,000 are available to support projects that will increase youth interest, engagement and skills in invasive species management in Victoria.

The grant program is open to community groups, education providers and local councils, with a focus on projects that connect with young people and develop their skills, and therefore deliver broader benefits for local communities.

The program aims to increase young people's participation in community environmental projects and encourage new ideas and innovations in the invasive species challenge. Funding can be used to support the engagement of young people in existing groups and initiatives, or to develop new youth-focused initiatives.
